TERMS AND CONDITIONS

1. An individual/corporate member must maintain a total average daily balance (ADB) of at least P100,000/P500,000 in his/her/its RCBC savings and checking account/s in order to keep his/her/its Hexagon Club membership.
2. On a periodic basis, RCBC may perform review of the account to ensure ADB is still within standards to qualify for the membership to the Hexagon Club. Corresponding charges may be imposed to the account subject to pertinent laws and regulations.
3. RCBC may collect, use, process, store, and/or update the member's information, including account information and/or share the same with RCBC Bankard Services Corporation, other YGC subsidiaries and affiliates, as well as selected third parties, for the purpose of (a) processing his/her/its application; (b) the delivery of any services, perks and privileges in relation to or his/her/its membership; (c) offering selected products and services that are relevant and necessary in the administration of his/her/its account/s and/or membership, including but not limited to product/service improvements/upgrades, data analytics and related automated processes as part of RCBC's initiatives to further improve its services. For this purpose, the member hereby waives, to the extent allowed by law, any and/or all rights to confidentiality of his/her/its account and personal information, under the Republic Act No. 1405 (the Law on the Secrecy of Bank Deposits), Republic Act No. 6426 (the Foreign Currency Deposit Act of the Philippines), Republic Act No. 8791 (the General Banking Law of 2000), the Republic At No. 10173 Data Privacy Act of 2012), and any other law, rule, or regulation protecting the privacy of information and confidentiality of deposits and transactions with banking institutions.
4. RCBC shall be authorized to issue a complimentary RCBC Bankard Hexagon Club credit card to Hexagon Club Privilege members. The RCBC Bankard Hexagon Club credit card, once activated by the member, shall be subject to RCBC's applicable terms and conditions for such credit card.
5. The member acknowledges his/her/its responsibility in ensuring that his/her/its bank records are current and updated. The member shall inform RCBC of any change therein in writing or by visiting any branch. RCBC shall not be responsible for any consequences that may arise as a result of the member's failure to timely notify RCBC of any change in his/her/its mailing address, contact details or other information.
6. Vouchers for the perks and privileges will be sent together with the welcome kit. These must be presented to any RCBC Branch when availing of the perks and privileges.
7. RCBC will not be liable for any lost vouchers. Lost vouchers will not be replaced and the value thereof will be forfeited. Availment of all perks and privileges shall be in accordance with the guidelines set by RCBC and/or its partners.
8. Vouchers are deemed used once they are surrendered by the member to RCBC in exchange for the chosen freebie/reward.
9. RCBC is not liable for any perks and privileges that are not available at the time of availment.

The member hereby agrees that RCBC and its offices, branches, subsidiaries, affiliates, agents, representatives and authorized third parties may, from time to time, send or communicate with the member via SMS, email and/or other means available in the future for reminders, notices, promotional advertisements/campaigns concerning the account/s of the member and other bank products and services.

The member hereby agrees that all notices and communications are deemed to have been duly received by him/her/them if hand delivered to or sent by registered mail to the address that he/she/it had provided to RCBC, or if sent by email and/or by other means available in the future. The member also agrees that he/she/it will be deemed notified of any changes in relation to his/her/its account/s if such changes are either duly posted in conspicuous places in RCBC branches, published in a newspaper, or sent by registered mail, SMS, email or other means available in the future.

- 14. Similarly, RCBC may reinstate members as it sees fit. Reinstatement may only be done at the end of the calendar year and will be effective on the next calendar year.
- 15. RCBC does not authorize banking transactions, such as deposits, withdrawals, payments, loans, etc., undertaken outside bank premises, except for such exceptions as may be allowed by RCBC and as may be provided under the law. Any transaction entered into with any bank personnel outside bank premises and not falling under lawful exceptions shall not be recognized by RCBC and shall be deemed to have been entered into without the proper authority.
- 16. These Terms and Conditions and may be amended from time to time by RCBC in its sole and absolute discretion without prior notice. These Terms and Conditions may be modified, amended, added, deleted or varied by RCBC by way of posting on RCBC's website, or in any matter deemed suitable by RCBC. The member undertakes to access the RCBC website regularly to view these Terms and Conditions. RCBC shall not be liable for any consequential or indirect damage or for any loss of value or benefits that may arise as a result of any changes made to these Terms and Conditions.

The member hereby agrees that, when RCBC amends these Terms and Conditions, the then-current version of these Terms and Conditions supersede all prior versions and govern the member's account/s and/or membership herein. The member hereby acknowledges and agrees that, by keeping his/her/its account/s open and using the same, as well as continuing to enjoy his/her/its membership and availing of the perks provided therefor, he/she/it is deemed to have accepted and agreed to any and all changes that RCBC may hereafter make to these Terms and Conditions and to be bound by the same. The member further understands that if he/she/it does not agree with said changes, he/she/it may close his/her/its account/s and/or terminate his/her/its membership as provided in these Terms and Conditions.
