Minutes of the Annual Stockholders' Meeting

(For approval of the Stockholders at the 2022 Annual Stockholders' Meeting)

Date : **28 June 2021**

Time : **4:00 PM**

Place : Virtual Meeting <https://www.rcbc.com/ASM2021>

Pursuant to notices served to all stockholders, the Annual Stockholders' Meeting of Rizal Commercial Banking Corporation (the "Bank") was held on June 28, 2021 at 4:00 PM and conducted virtually via <https://www.rcbc.com/ASM2021> in view of the COVID-19 pandemic.

Chairperson Helen Y. Dee presided over the meeting, while the Corporate Secretary, Atty. George dela Cuesta, recorded the proceedings. Calling the meeting to order, Chairperson H. Y. Dee explained that for the second time, the meeting is being held in a virtual format due to the current pandemic. She welcomed the shareholders who joined the live webcast, those participating in the meeting through voting *in absentia* and those who appointed her as proxy. She then introduced those who are joining her in the meeting, Mr. Eugene Acevedo, President and CEO, and Atty. dela Cuesta.

Thereafter, the Chairperson asked the Corporate Secretary whether proper notice of the meeting was sent to each stockholder of record and whether there was quorum for the transaction of business.

I. Proof of Notice — The Corporate Secretary explained that notices for the meeting were duly served to all stockholders of record as of May 31, 2021 in three ways as allowed by prevailing SEC Rules and Circulars: (a) by posting on the Bank's website, (b) by disclosure in the Philippine Stock Exchange (PSE), and (c) by publication for 2 consecutive days on May 31, 2021 and June 1, 2021, in the print and online business section of two newspapers of general circulation, namely The Philippines Star and Manila Bulletin. (The list of stockholders as of Record Date May 31, 2021 is hereto attached as *Annex "A"* and made an integral part of the minutes.)

II. Quorum — The Corporate Secretary reported that stockholders owning a total of 1,751,751,370 common and preferred shares representing 90.49% of the total outstanding common and preferred shares entitled to vote were present. (The list of stockholders who were present is hereto attached as *Annex "B"* and made an integral part of the minutes.)

In view of the foregoing, the Corporate Secretary certified the presence of a quorum.

All the members of the Board of Directors and other officers of the Bank and representatives of Punongbayan & Araullo were in attendance through the live webcast. (The list of directors and officers of the Bank present is hereto attached as *Annex "C"* and made an integral part of the minutes.)

The presence of a quorum being ascertained, the Chairperson declared the agenda open for deliberation.

III. Instructions on Rules of Conduct and Procedures — The Chairperson said that while the meeting is being held in a virtual format due to the government regulations that prevented people from conducting in-person meetings, the Bank strived to provide the shareholders the opportunity to participate in the meeting.

The Corporate Secretary reported that the rules of conduct and voting procedures are set forth in the Notice of the Annual Stockholders' Meeting. He highlighted the following points:

1. Only Stockholders who notified the Bank by email at RCBC-ASM-2021@rcbc.com until 5:00 p.m. of June 20, 2021 and who duly registered by email are allowed to access the virtual meeting at <https://www.rcbc.com/ASM2021>.

2. Only those who registered were allowed to send their questions or comments on the agenda items to CorSecRCBC@rcbc.com. And only those questions the Bank received by 5:00 pm of June 25, 2021 were considered for the open forum at the stockholders' meeting.

3. The Bank will reply by email to questions and comments it received, if any, after June 25 up to 4 p.m. of June 28, 2021.

The process for stockholders to ask questions was provided in the Procedure for the Annual Stockholders' Meeting attached to the Definitive Information Statement.

4. As indicated in the ballot for the voting of shareholders, there are six resolutions proposed for approval by the stockholders in the meeting. Each proposed resolution will be shown on the screen as the same is being taken up.

5. Stockholders or their representative cast their votes on the proposed resolutions by completing, dating, signing and emailing/sending the proxy form/ballot form to the Bank via RCBC-ASM-2021@rcbc.com together with the stockholder's registration mail by 5:00 P.M. of June 20, 2021. If the name of the proxy is not specified, the stockholder shall be deemed as having appointed the Chairperson as proxy.

6. The Bank has tabulated the votes cast after the end of the proxy validation process. Those votes are from stockholders representing 90.49% of the total outstanding shares.

To count and/or validate the votes of the meeting, the Bank has engaged an independent party, Punongbayan & Araullo.

The Definitive Information Statement and the Explanation of Agenda Items also provides that (1) only stockholders of record at close of business on May 31, 2021 will be entitled to participate and vote at the meeting or any adjournment thereof; (2) only duly registered stockholders shall be counted for purposes of quorum; and (3) where no specific instruction is clearly indicated in any, some or all of the items specified in the proxy form/ballot form, the vote shall be deemed as a vote "FOR" with respect to proposal 1 to 6 (*i.e.*, Items IV to VII and IX hereof) in the forms and "FOR ALL" with respect to proposal 7 (*i.e.*, Item VIII hereof) in the forms.

IV. Approval of the Minutes — The Chairperson explained that an electronic copy of the minutes is available on the website of the Bank and was attached to the Definitive Information Statement.

The Corporate Secretary reported that Management is proposing the adoption of Resolution No. 21-01 (as shown below) and that stockholders representing 1,751,004,935 shares or 99.96% of the votes cast, voted in favor of approval of the minutes of the Annual

Stockholders' Meeting held on July 27, 2020. Accordingly, the following resolution was approved:

Resolution No. 21-01

"BE IT RESOLVED, AS IT IS HEREBY IS RESOLVED, That the stockholders hereby approve, confirm and ratify the Minutes of the Annual Stockholders' Meeting held on July 27, 2020, copies of which are posted on the Bank's website, and attached to the Definitive Information Statement."

V. Approval of the Annual Report and Audited Financial Statements for 2020 — The Annual Report and the 2020 Audited Financial Statements of the Bank, copies of which are available at the Bank's website, the PSE Edge and which were also attached to the Definitive Information Statement, were explained and submitted to the stockholders for approval.

The Annual Report together with the Definitive Information Statement includes, among others, the following matters: (a) an explanation of the dividend policy and dividend payments; (b) material information on the current stockholders and their voting rights; and (c) a detailed, descriptive and balanced assessment of the Bank's performance. The duly signed and certified Audited Financial Statements also includes a statement on the adequacy of the corporation's internal controls or risk management systems, and a statement of all external audit and non-audit fees.

Mr. Acevedo presented his report to the Stockholders. He started his report by highlighting the launch by RCBC of its new campaign "Partners through Generations". This campaign articulates what sustains the Bank's business and such draws upon the strong relationships and partnerships RCBC has built over the last 60 years. Now, more than ever, RCBC needs to be the best partner in every role it plays: the best bank for its customers, the best employer for its people, the best partner for government organizations, and the best corporate citizen for its country.

He said that the pandemic puts banks on the frontline and RCBC is an active part of the solution. He cited the following actions taken by RCBC:

- a. RCBC activated its Pandemic and Infectious Disease Plan to manage the impact of the pandemic to its people and its business. The Bank enforced health and safety protocols to protect its RCBC bankers, especially those in its branches.
- b. RCBC moved with haste to minimize business disruptions as well as transform the way RCBC works. The Bank shifted to Work from Home mode and virtual meetings while ensuring that its IT infrastructure can support these.
- c. RCBC rationalized its branch network by closing 56 branches as foot traffic declined and as customers shifted to digital platforms.
- d. For customers severely affected by the pandemic and may take time to recover, RCBC launched the COVID Assistance and Recovery (CARE) Program as a pre-emptive refinancing of their loans.
- e. To manage the higher risks and to preserve the Bank's asset quality in the event of a continuous economic downturn, RCBC set aside Php9.4 billion in loan loss provision, 2.5 times higher than last year.

Mr. Acevedo reported that the Bank's efforts have been recognized as the Philippines Domestic COVID Management Initiative of the Year was awarded to RCBC by the Asian Banking and Finance (ABF) Wholesale Banking Awards 2021.

Mr. Acevedo said that after putting all RCBC's defenses in place, the Bank unleashed its arsenal of digital solutions. He shared that this is a battleground the Bank has been preparing for. He cited the following actions of the Bank:

- a. Before the ECQ, the Bank already established a Board-approved Digital Committee, which enabled the Bank to quickly provide essential digital services during the lockdown.
- b. RCBC fortified its IT infrastructure to accommodate the heavy influx of online banking transactions.
- c. RCBC Mobile App became even more powerful in 2020. RCBC went above and beyond by providing more capabilities so its customers can bank from home. In July 2020, RCBC launched DiskarTech.

He proudly reported about RCBC's success in the digital space, shown by the surge in digital transactions by 183% in customer enrolment since March 2020. The Bank's Send Cash, Cardless Withdrawal, and Online Check Deposit features had a surge in utilization rate by as much as 1,300% compared with pre-quarantine levels in 2020. DiskarTech has set a national record for being the fastest to reach one million downloads after only 30 days and an enrolment speed of as much as 1.3 downloads per second.

For these programs, RCBC was awarded as Best Digital Bank, Most Innovative Internet Banking Services Provider and Best Digital Inclusion Initiative for Service and Solution by industry experts and peers, such as Alpha Southeast Asia, Asiamoney, The Global Economics and the International Innovation Awards.

While RCBC strives to be ahead in the digital race, at the end of the day, the only thing that matters is if RCBC is able to put these innovations to good use by solving society's problems. He shared the following actions of the Bank:

- a. RCBC led a private sector coalition called *Damayang Sambayanihan: Hatid-Ayuda sa Kababayan*. This was a quick-response initiative to ensure the timely disbursement of Php200 billion (USD4 billion) in emergency government aid.
- b. RCBC became the first private universal bank authorized by the Department of Social Welfare and Development (DSWD) and the Bangko Sentral ng Pilipinas (BSP) to accept and disburse government funds.
- c. To ensure the timely distribution of aid to 18 million families nationwide, RCBC deployed its 2,000-strong handheld RCBC ATM Go network. By end-2020, RCBC had managed to digitally disburse Php12.43 billion (USD258.71 million) in cash subsidy to more than 3.3 million households or approximately 16.6 million individuals in 72 out of 81 provinces.
- d. While 2020 was a trying time for many, RCBC continued to sharpen its focus on sustainability efforts. It has funded a total of 9,950 green and social projects amounting to more than Php51.0 billion as of end-2020 or 10.5% of its total loans.
- e. The Bank has also taken the lead roles in financing some of the country's biggest green infrastructure and renewable energy projects. RCBC stopped funding new coal-fired power plants in the country, aligned with the policy decision of the Department of Energy to shift to a renewable energy mix.

For these projects, the Bank garnered awards such as Best Sustainability Bond in the Philippines from the Asset Asian Awards, Philippine Domestic Initiative of the Year for Sustainable Financing from ABF Wholesale Banking Awards and Best Green Bank Philippines from Global Banking and Finance Awards.

Despite the many unexpected challenges, the Bank performed relatively well. In 2020, its gross revenues rose 6.0% to Php37.9 billion from Php35.9 billion in 2019. Net interest income also jumped by 17.5% to Php26.3 billion amid a decline in funding costs and higher margins. Its loan book expanded 5.0% to Php456.6 billion while total deposits reached Php535.8 billion, fuelled by a 21.0% surge in low-cost CASA deposits. RCBC is the only major bank in the country that saw a rise in loans during the pandemic.

With the Bank's loan loss provision of Php9.4 billion, RCBC ended 2020 with a net income of Php5.0 billion, just 7% lower than Php5.4 billion the previous year. Amid the

crisis, RCBC managed to keep its net non-performing loan ratio at 2.9%. The Bank remains more than adequately capitalized, as its CAR ratio stood at 16.1% while its common equity Tier 1 ratio was at 12.6%.

RCBC continued to reap rewards during the first half of 2021. The Bank just received three Best Digital Bank awards. RCBC was also recognized as Best Cash Management and Retail Bank by Global Banking and Finance.

These recognitions serve as a testament to the Bank's collective strength. He stated that in the moment when the Bank's customers, employees, and its country needed it most, the Bank came together as one RCBC Family.

While COVID continues to paint a cloud of uncertainty, RCBC must not lose sight of its purpose, its shared values, and its commitment to a shared future. He urged RCBC to turn this pandemic into its "golden hour". He stressed that the building of partnerships is not just with RCBC's customers, but also with each other.

He asked his colleagues in RCBC: as RCBC Bankers, they must live what they promise, that through collaboration, agility and care – we must continue to go beyond expectations for those we serve.

Mr. Acevedo ended by giving gratitude to the Chairperson and to the members of the Board of Directors for steering the Bank to the right direction.

The Chairperson thanked Mr. Acevedo for his report.

The Corporate Secretary then reported that Management is proposing the adoption of Resolution No. 21-02 (as shown below) and that the stockholders representing 1,751,004,935 shares or 99.96 % of the votes cast, voted in favor of the approval of the Bank's Annual Report and its Audited Financial Statements for the year 2020. Accordingly, the following resolution was approved:

Resolution No. 21-02

VI. Ratification of actions of the Board of Directors, different Committees and Management — The next item considered was the ratification of the actions of the Board of Directors, the different Committees and Management of the Bank from July 27, 2020 to the date of the meeting, June 28, 2021. The Corporate Secretary described the transactions subject of the ratification.

Thereafter, he presented Resolution No. 21-03 (as shown below) and reported that stockholders representing 1,751,751,370 shares or 100 % of the votes cast voted in favor of the approval, confirmation and ratification of the actions of the Board of Directors, the different Committees and the Management from July 27, 2020 to June 28, 2021. Accordingly, the following resolution was approved:

Resolution No. 21-03

"BE IT RESOLVED, AS IT IS HEREBY IS
RESOLVED, That the stockholders hereby approve, confirm
and ratify, the actions of the Board of Directors, different
Committees and Management from July 27, 2020 to June 28,
2021."

VII. Confirmation of Significant Transactions with DOSRI and Related Parties — The confirmation of significant transactions with DOSRI and related parties approved by the Board of Directors, the different Committees and Management of the Bank from July 27, 2020 to June 28, 2021 was then considered.

The Corporate Secretary reported that significant transactions with DOSRI and related parties from July 27, 2020 to June 28, 2021 include: loans/receivables and deposit liabilities; trading of investment securities; lease and sub-lease with RCBC Realty Corporation; various service agreements with RCBC Bankard Services Corporation, RCBC Forex Brokers Corporation, RCBC Capital Corporation, RCBC Securities, Inc., Rizal Microbank Inc., RCBC Leasing and Finance Corporation, Niyog Property Holdings, Inc., RCBC International Finance Limited; and lease agreement with RCBC Rentals Corporation for the lease of ATMs. He added that the subject transactions include the administration and management of the retirement funds of some of the subsidiaries, service agreements, leasing office premises to subsidiaries, accreditation of RCBC Trust agent and of insurance companies, and regular banking transactions.

Details of said related party transactions are disclosed in the Bank's SEC 17-A Report which is also available on the Bank's website. These were also provided in the Annual Report together with the Definitive Information Statement.

The Corporate Secretary then presented Resolution No. 21-04 (as shown below) and reported that stockholders representing 1,751,702,330 shares or 99.997% of the votes cast, voted in favor of the approval, confirmation and ratification of the significant transactions with DOSRI and related parties approved by the Board of Directors, the different Committees and Management from July 27, 2020 to June 28, 2021. Accordingly, the following resolution was approved:

“BE IT RESOLVED, AS IT IS HEREBY IS RESOLVED, That the stockholders hereby approve, confirm and ratify, the significant transactions with DOSRI and related parties approved by the Board of Directors, the different Committees and Management July 27, 2020 to June 28, 2021.”

VIII. Election of Directors — The next item in the Agenda was the election of Directors of the Bank for the year 2021-2022. Before the election, the Corporate Secretary reported to the stockholders the annual compensation of each of the directors. He explained that the Bank is sharing the information in compliance with Corporate Governance Regulations of the SEC and the Revised Corporation Code.

The Corporate Secretary then shared the findings of the Institute of Corporate Directors (or ICD) when it audited the processes of the Board. ICD highlighted that with the Golden Arrow Recognition received by the Bank from the SEC, “the Bank is considered as one of the model enterprises for corporate governance in the Philippines.” ICD also stated that the RCBC Board is composed of “working” directors who are able to contribute their expertise and competencies in their respective Board Committees and to the Board. Finally, the assessment corroborates that the RCBC Board is ably led by Chairperson, Helen Y. Dee, while President and Chief Executive Officer, Eugene S. Acevedo, effectively leads the management of the Bank.

The Corporate Secretary reported that each of the fifteen nominees for director has garnered at least 99.995% of the votes cast and consequently certified that each of the nominees has received sufficient votes for election to the Board of Directors of the Bank.

The Corporate Secretary reported that stockholders representing 1,750,955,895 shares or 99.95% of the votes cast, voted in favor of the approval of the re-appointment of Punongbayan & Araullo as auditor of the Bank for the fiscal year 2021. Accordingly, the following resolution was approved:

X. Other Matters — The Chairperson asked if there were questions or comments received from the stockholders. The Corporate Secretary informed the Chairperson that there were no questions received from the stockholders.

XI. Adjournment — There being no other business to transact, the meeting was adjourned at 04:36 P.M.
