Please be advised of the following significant items approved by the Board of Directors at the regular meeting held on August 29, 2023.

1. Cash Dividend Declaration on Convertible Preferred Shares

The declaration covers cash dividends for the Bank's convertible preferred shares amounting to P0.19203 (US\$0.00350) per share or a total of P51,351.24 (US\$935.70 @ P54.880). The cash dividend is payable to holders of convertible preferred shares as of September 21, 2023 (record date) and payable within 5 trading days from record date. The actual and final amount of the cash dividends may be lower if there are additional conversions to common stock prior to and up to September 21, 2023. The dollar equivalent of the cash dividend, however, would depend on the prevailing exchange rate on September 21, 2023.

The cash dividend is for unlisted preferred shares.
