We are writing to inform the Exchange that Rizal Commercial Banking Corporation (RCBC) has announced terms for a US\$ Unsecured Reg S Sustainability Notes due [2030] (the "Notes"). The Notes will be issued via a drawdown under RCBC's US\$4,000,000,000 Medium Term Note Program. The Notes will be listed on the Singapore Exchange Securities Trading Limited. The pricing is expected during European trading hours today.

Use of Proceeds:	The net proceeds from the issue of the Notes will be applied by RCBC to support and finance and/or refinance the RCBC's loans to customers or its own operating activities in eligible green and social categories as defined in RCBC's Sustainable Finance Framework
